

PRIVACY POLICY

Language Stars, LLC (“Language Stars”, “We”, or “Us”), a limited liability company operating under the laws of the state of Illinois, operates <http://www.LanguageStars.com> (“Service”). Language Stars takes the privacy of those visiting our web site (“Users” or “you”) very seriously. This page informs you of our policies regarding the collection, use and disclosure of Personal Information when you use our Service because Users have the right to know what information we collect, how it is protected and used, and the circumstances under which it may be disclosed. This Policy describes the various ways that we collect and treat information and content provided by Users so as to enhance your use of our services while at the same time protect your privacy. Please read this Policy carefully, as your use of Language Stars services constitutes your acceptance of and agreement to the terms and conditions of the Policy. Do not use our services if you do not agree with the terms and conditions of the Policy. This Policy does not cover information collected other than on or through the web site, including without limitation offline and on sites linked to from the web site and application. It does however cover social media accounts of Language Stars. This Policy may be modified from time to time without advance notice. Type of Information We Collect

Our services collect the following personally identifying information: name, email address, phone number, address, languages of interest, age of student, and payment information. We also ask the best time to contact clients, how clients heard of our Services, languages of fluency for users and job applicants, and may request through the website resumes, positions of interest, and confirmation of ability to work in the United States from our applicants.

Our servers may also collect information regarding your usage of our services, including without limitation the pages you visit, the browser software and operating system you use, your internet service provider, your Internet Protocol address, referring / exit pages, date / time stamp and clickstream data. Additionally, the Services utilize user-specific analytics that measure individual use of the site, including but not limited to which videos have been viewed, internal pages visited, duration of visit, and user comments.

We may supplement the information we collect about you online with outside records from third parties to enhance our ability to serve you, to tailor our content to you, and to offer you opportunities to purchase products or services that we believe may be of interest to you. We may combine the information we receive from those sources with information we collect through our



services. In those cases, we will apply this Policy to any information received from third parties, unless we have disclosed otherwise.

How We Use the Information We Collect

Unless you have opted out of receiving promotional materials or notifications from us, we may periodically use your email address to send you such materials and notifications. If you want to stop receiving such materials and notifications from us, you can contact us at the information below to alert us to your preference. In addition, you can opt out of, or unsubscribe from, receipt of such e-mails at any time by following the instructions contained in those e-mails.

By submitting Social Media Content via any social media provider, you (i) disclaim any ownership under any copyright right, privacy or publicity right, attribution right or any other right over, relating to or concerning any such Social Media Content and (ii) expressly authorize and license us to reproduce, print, publish and disseminate any such Social Media Content on the web site or in any other media for any purpose. Your information may be provided to third parties that manage or administer certain sections or features of the web site and mobile application, in which case the information may be used by us and by any such third party, each pursuant to its own policies. We may also provide your information to our advertisers, so that they can serve ads to you that meet your needs or match your interests. While we will seek to require such third parties to follow appropriate privacy policies and will not authorize them to use this information except for the express purpose for which it is provided, we do not bear any responsibility for any actions or policies of third parties. To the extent we are legally required to provide access to our database in order to cooperate with police investigations or other legal proceedings, in those instances, the information is provided only for that purpose.

Third Parties

If you provide us with your personal information, we may transfer that information to our third-party service providers. The services provided by our third-party service providers may include payment processing and marketing assistance, performing business and sales analysis, and/or supporting our web site functionality. We also share your name, contact information and credit card information with our authorized service providers who process credit card payments.



These service providers may have access to personal information needed to perform their functions, and will process it in accordance with their privacy policies.

These analytics providers may use cookies and other technologies to perform their services, and may combine the information that they collect about you on our web sites with other information that they have collected. This Policy does not cover such third parties' use of the data.

Language Stars may also disclose your information if required to do so by law, court order, subpoena or other legal process, as requested by a governmental or law enforcement authority.

Additional Web Site Viewing Information

The web site may use cookies (i.e., files / information placed by a web site on your computer to facilitate future use) internally, they may be used by third parties such as network advertisers to serve advertisements and may use third party analytics service providers to evaluate and provide us with information about the use of our Service and viewing of our content. Network advertisers are third parties that display advertisements based on your visits to the web site and other web sites you have visited.
